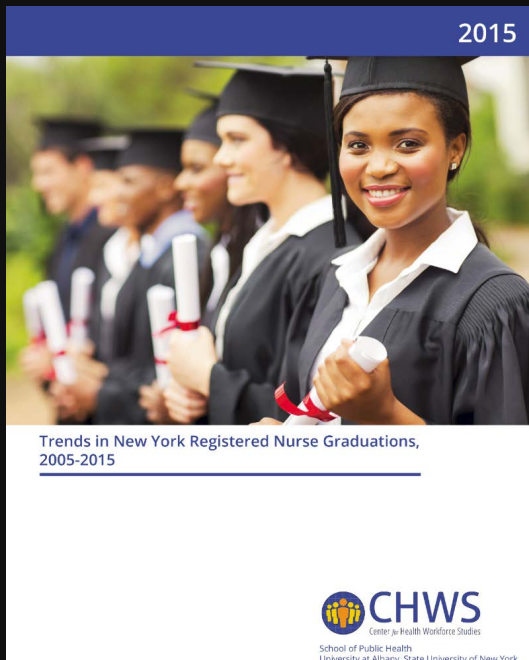




Nursing Education Report Goes Viral



Our [Trends in New York Registered Nurse Graduations, 2005-2015](#) report shows trends in the production of new nurses in New York. While RN production continues to increase in New York, most of the recent growth can be attributed to the increased number of BSN completers, those RNs with nursing diplomas or associate degrees who go back to school for their Bachelor of Science in Nursing. If this trend continues, production of newly trained RNs may decline. Additionally, newly trained RNs are having continued difficulty finding jobs, especially new RNs with associate degrees.

Following a press release regarding the report, CHWS Director Jean Moore was interviewed last Friday by a local news reporter. The resulting article was posted to over 40 publications nationwide, including the *Washington Times*, *Charlotte Observer*, *Miami Herald*, and *San Francisco Chronicle*. This was the twelfth year that CHWS conducted the survey of New York RN education programs, where deans and directors of RN education programs were asked questions about applications, admissions, and RN graduations from their programs, as well as barriers to expanding student capacity and their assessment of the local job market for newly trained RNs. The primary goals of this analysis are to document trends in RN graduations regionally and statewide and to understand how these trends may affect the supply of RNs in New York.

The Primary Care Workforce in New York

Although the need to expand primary care services is widely acknowledged, there is concern that primary care practitioners are not well distributed across the state. At present, New York has 93 federally designated primary care health professional shortage areas (HPSAs), with 70 special population designations (ie, low-income or Medicaid-eligible populations) and 23 geographic designations. More than 4 million New Yorkers reside in these primary care HPSAs. Understanding the supply and distribution of primary care providers is necessary to ensure that the health care needs of all New Yorkers are met in an evolving health care delivery system.

State University of New York (SUNY) medical schools are an important producer of physicians in New York State. Moreover, every SUNY medical school awards more medical degrees on average annually than any other medical school in New York State. Nearly 1 in 5 of New York physicians is a graduate of a SUNY medical school and/or received graduate medical training in a SUNY-sponsored program.

Works in Progress

Oral Health in Kentucky

CHWS recently received funding support from the Pew Charitable Trusts to conduct an environmental scan of oral health in the state of Kentucky. The project work will include an extensive literature review of past policy and program initiatives to improve population oral health in the state. In addition, CHWS researchers will analyze state and national data to describe the current oral health status of Kentucky's population and identify gaps in service capacity that impact access to services. Project staff will also engage a variety of stakeholders in oral health in interviews to provide specific context to the delivery of oral health services in Kentucky. The project work is guided by a state-based project advisory committee convened to support the research.
